Here's How it Works

Example 1

Financial Professional Fred sells 3 FIA contracts totaling \$600,000 and 5 Multi Year Guaranteed Annuity (MYGA) contracts totaling \$400,000.

Incentive Calculation:

- **\$1,500:** ($\$600,000 \times 0.25\%$) for the 3 FIA contracts
- **\$4,500:** ($\$600,000 \times 0.75\%$) for the 3 FIA contracts because total annuity production reached \$1 Million

Total Incentive Bonus Paid: \$6,000

Example 2

Financial Professional Fiona sells 5 FIA contracts at \$200,000 each and a 6th FIA contract for \$500,000 before the program ends.

Incentive Calculation:

- **\$2,500:** ($\$1,000,000 \times 0.25\%$) for the first 5 FIA contracts
- **\$7,500:** ($\$1,000,000 \times 0.75\%$) for the first 5 FIA contracts because total annuity production reached \$1 Million
- **\$3,000:** ($\$300,000 \times (0.25\% + 0.75\%)$) as a True-up after the end of the program because the 6th FIA case was \$300,000 larger than the case it replaced

Important Information
